Moot Court is a simulated oral argument, similar to an argument made before an appellate court. The argument lasts for a given time, during which time the participating contestant presents an argument and answers questions posted by the panel of judges. It is not a trial; there are no witnesses and no evidence. The arguments are evaluated on the application of the law to the facts of the case. Moot Court members research their respective sides, write appellate briefs and present oral arguments in front of the judges. Judges are free to ask questions at any time during the presentation and students must respond acordingly; therefore, a profound understanding of the facts of the case, their arguments, and their opponents' arguments' is required.

Mooting also helps you to build confidence in public speaking, general research and presentation skills. In other words, mooting experience can benefit every student whether or not they plan to follow a traditional legal carrer path upon graduation.

The Moot court will be primarily to enable students to collate their knowledge, skill and persuasive power in focus and deliberate the trial cases and elaborate their arguments to overcome those presented by the opposing teams.

THE COMPETITION PROGRESSESS IN FOUR SEQUENTIAL STEPS

The second step in that the participating institutions must send in the name of the student participation giving all particulars as the 'rules and regulations' require. The names of the registered student participant enables them to make a written analysis of the 'moot problem' with a written memorial.

The first step in the competition is the invitation extended to all law schools. The participating schools have to register within the time specified to be able to participate in the Competition. The registering institutions will receive the 'moot problem' which will be the initial activity to be performed by all institutions willing to take part in the completion.

The memorials will be received by the School of Law, provided they are sent by the participating institutions before the specified date and time. These memorials will be sent to a panel of experts to review the analysis and arguments. The assessments will be collated and a maximum of 30 teams will be invited to made the 'oral presentations' of the memorials to a panel of judges.

The final step in the competition is the 'round of oral presentations' which will progress as a process of elimination.

Two teams will be pitched against each other and the winning team progresses from the semi-final to the final round of the competition. The finalist will be in two positions—winner and ronners up.
