Reg.. **RESOLUTION OF ESSENTIAL PENDING ISSUES RELATING TO PROVISION OF CIVIC AMENITIES IN NOIDA CITY.**

At the outset, may we express our sincere thanks to you for a patient hearing and positive response to almost all the issues raised by us at our last meeting with you. However, Since then we have been awaiting to receive the action taken report thereon. We once again seek your kind intervention in resolution of the following key issues concerning residents of Noida, which have already been taken up by us..

I. PERIODICAL MEETINGS WITH FONRWA AND RWAs.

May we submit that for quite a long time, the system of periodical meetings with FONRWA and RWAs of the Sectors has not been in existence. You will kindly appreciate that such a regular interaction helps in speedy resolution of the pending issues. We would, therefore, earnestly request you to kindly issue necessary directions for holding regular periodical meetings with FONRWA and RWAs. Furthermore, the earlier system of visits of the concerned senior officials, may also kindly be revived.

II. ISSUANCE OF PASSES TO OFFICE-BEARERS OF RWAs FOR ENTRY IN NA

BUILDING. As you are aware, Residents Welfare Associations (RWAs) have been formed in almost all the Sectors of Noida and that they have been actively following up the issues relating to development & welfare of their Sectors. Thus they are required to visit the office of Noida Authority quite frequently, almost on daily basis. At times, there are long queues at the pass counters, and hence the office-bearers of RWAs and FONRWA, get late in attending the scheduled meetings with the concerned officials of NA. May we, therefore, earnestly appeal that requisite system for issuance of regular passes for them may be devised and alternatively, necessary directions may be issued for entertaining the passes issued by RWAs themselves.

III. CLEARANCE OF RWAs IN EXECUTION OF WORKS IN SECTORS: It has been

experienced that contractors undertake the works in the sectors without the knowledge of RWAs and submit the execution/completion thereof directly to NA even though works remain incomplete or having been unsatisfactory finished. May we request that system of obtaining NOCs from RWAs, both before commencement and after completion of the works, may please be put into operation.

IV. HEALTH & SANITATION JOBS BY CONTRACTORS: In certain sectors, work relating to sweeping of roads, cleaning of storm water drains and lifting of kachhra from the houses, has been entrusted to the contractors. Member RWAs of such sectors have expressed great un-satisfaction with the system as the contractors do not coordinate with RWAs. May we, therefore, request that the system may be suitably modified where-under RWAs' involvement is ensured.
