Reg.. **RESOLUTION OF ESSENTIAL PENDING ISSUES RELATING TO PROVISION OF CIVIC AMENITIES IN NOIDA CITY.**

May we refer to our meeting with you on 30.11.2015 and another meeting taken by the ACEO, Shri Rajesh Prakash ji, on 3<sup>rd</sup> June, 2016, as also our various follow-up meetings with ACEO, DCEO. and other senior officials.

We regret to submit that even though we have had positive response at the meetings, regretfully, no tangible action has been taken in regard to any of the issues taken up by us. Even the minutes and/or action taken reports have not been issued to us. We recapitulate hereunder the most critical and pressing issues concerning residents of Noida:

#### **I.. CRITICAL NEED FOR CONSTRUCTION OF BOUNDARY WALLS:**

May we reiterate that in the absence of boundary walls around Sectors of Noida city, security of the residents of Sectors of Noida city is being adversely affected. Most of the Sectors of Noida city are unbound. **RWAs of Sectors of Noida have got installed security gates on the periphery of their Sectors, but the same are not bearing the desired results even though CCTVs have also been provided by them.** This is so because yet there are several openings around the Sectors wherefrom the criminals and bad elements enter the Sectors and easily escape through such openings after indulging in criminal activities. In respect of certain sectors, villages are adjacently mingled on one or two sides of their periphery, which also provide similar openings and result in security hazards and thus require construction of segregating boundary walls.

#### **II. ACCELERATED DRIVE FOR CLEANING OF NALAS AND STORM WATER DRAINS.**

We wish to bring to your kind attention that NALAS and storm water drains in residential Sectors are not being cleaned on regular basis. Even though monsoon season is already round the corner, regrettably, requisite work has still not been initiated in some Nalas and very little progress in the case of some others, has been made. You will kindly appreciate that it is most critical to have the NALAS and storm water drains cleaned regularly on quarterly basis, with a view to avoid outbreak of dreaded diseases like dengue and malaria.. To rid the residents of facing continued unhygienic condition, requisite plan may be devised to cover NALAS, as a long-term solution.
