### III. CONVERSION OF NOIDA LEASE HOLD LAND INTO FREE HOLD.

As you are aware, our request for conversion of Noida lease hold land into FREE HOLD, has remained pending for quite a long period, despite our repeated communications and pleas made at several meetings. We have been explaining salient changed facts and circumstances, which fully justify conversion of Noida lease hold land into FREE HLLD.

Regrettably, we are not even being apprised of any reason for not considering the genuine request of Noida residents all these years. It may be recalled that several other associations too have been supporting the genuine demand and even large scale DHARNAS too have been held outside Noida Authority wherein thousands of Noida residents have participated.

In view of the continued pressure of residents of Noida, to resort to agitational programme, We have written a letter to the hon'ble Chief Minister, Uttar Pradesh, on 30.9.2016, requesting him for his kind intervention in resolution of our long pending demand. A copy of the letter was also sent to you. May we earnestly appeal to you to have the matter considered based on the merits of the case, explained by us and send requisite recommendation for conversion of Noida lease hold land into FREE HOLD.

IV. QUANTITY & QUALITY OF DRINKING WATER IN NOIDA CITY: Currently, due to stoppage of Ganga Water, there is a crisis of acute shortage of water. Consequently, several sectors of Noida have not been getting adequate supply and with low pressure, no supply is being received in first and second floors. Hence there is critical need to take effective measures for augmenting water supply.

We would like to reiterate that quantity of drinking water even otherwise, is quite inadequate as supply is available hardly for about 3/3-1/2 hours as against prescribed 7 hours. We have been receiving complaints against quality of drinking water, as the same contains lot of sediment and TDS levels too are quite high. It is, therefore, essential for mixing adequate quantity of Ganga Water. As already pleaded for by us, there is an essential need to provide filtration plants at all the water tanks.

V. RROSTER FOR RWA MEETINGS WITH PROOJECT ENGINEERS : In response to our request for periodical visits of the officials/engineers to the Sectors, we were asked to draw up a roster for RWA meetings with the Project Engineers, work-circle wise, to be held daily at 5.00 pm from Monday to Saturday.

We had, therefore, attempted to draw up the requisite roster for RWA meetings with the Project Engineers, work-circle wise and had submitted to the DCEO for necessary action. We have indicated phone numbers of Project Engineers and also given details of the sector to be covered by them on each day as also telephone numbers of the President/General Secretary of the concerned RWA. May we request for your kind directions for an urgent execution of the said roster.

VI. ISSUANCE OF PASSES TO OFFICE-BEARERS OF RWAs FOR ENTRY IN NA BUILDING. Residents Welfare Associations (RWAs) have been formed in almost all the Sectors of Noida. RWAs have been actively following up the issues relating to development & welfare of their Sectors. For this purpose, they are required to visit the office of Noida Authority quite frequently, almost on daily basis. It has been observed that at times, there are long queues, at the reception counters, of the persons seeking to obtain daily entry passes and consequently, the office-bearers of RWAs and FONRWA, get late in attending the scheduled meetings with the concerned officials of NA. Kindly issue necessary directions for issuance of permanent passes to the office-bearers of RWAs and FONRWA, for entry into NA building.
